2. Industrial Engineering and Management

2. National Board of Accreditation has decided that in all cases where UG Engineering programs of an Institution were granted accreditation for a period of 5 years in Tier-I/II January 2013 document, the period of accreditation of these program(s) shall be extended for one year subject to the condition that they meet the Pre-qualifiers for extension of duration of accreditation from 5 to 6 years. The Pre-qualifiers submitted by Siddaganga Institute of Technology, B H Road, Tumakuru, Karnataka 572103 in respect of the following UG Engineering programs for extension of duration of accreditation from 5 to 6 years have been considered.
