This has reference to your application I.D. Nos. 7791-06/02/2023 and 7802-08/02/2023 seeking accreditation by National Board of Accreditation to UG Engineering and PG-Master of Computer Applications programs in Tier I offered by Siddaganga Institute of Technology, B H Road, Tumakuru, Karnataka 572103.

2. Expert Teams conducted onsite evaluation of the programs from 12th to 14th January, 2024 and 09th to 11th February, 2024. The reports submitted by the Expert Teams were considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the programs as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. In respect of the program which has been granted accreditation for 3 years, Siddaganga Institute of Technology, B H Road, Tumakuru, Karnataka 572103 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to Siddaganga Institute of Technology, B H Road, Tumakuru, Karnataka 572103 as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
